The LOCALISED project published a report (LOCALISED Deliverable 5.1) with **250 indicators connecting Sustainable Development Goals (SDGs) and the Sustainable Energy and Climate Actions Plans (SECAPs)**, being two main instruments at regional and local level to implement mitigation, adaptation and energy poverty actions.

In a context where SDGs and the Sustainable Energy and Climate Actions Plans (SECAPs) are currently not aligned, the aim of the proposed indicators is to facilitate not only the **optimization of resources, but also the smart implementation of actions and the benchmarking between regions and cities.**

The report includes an extensive bibliographic review of local and regional SDGs adapted frameworks, and two complementary processes to gather relevant feedback from experts.

WHAT IS LOCALISED?

LOCALISED is downscaling national decarbonization trajectories consistent with Europe's net-zero target to the local levels in a way that would speed up the uptake of mitigation and adaptation actions in local administrations and businesses

- Duration: **48 Months**
(Starting date: 01/10/2021)
- EU contribution: **Horizon 2020 Framework Programme**
- Consortium: **12 organisations from 6 countries**

WHICH ARE THE TOOLS OF LOCALISED?

- **Climate Action Strategiser:** science-based tool focusing on how to better integrate mitigation and adaptation measures, and how to ensure a collaborative environment in local administrations of small and medium size
- **Net-Zero Business Consultant:** interactive online tool designed to communicate with end-users from the business sector and provide them with insights into effective mitigation and adaptation options

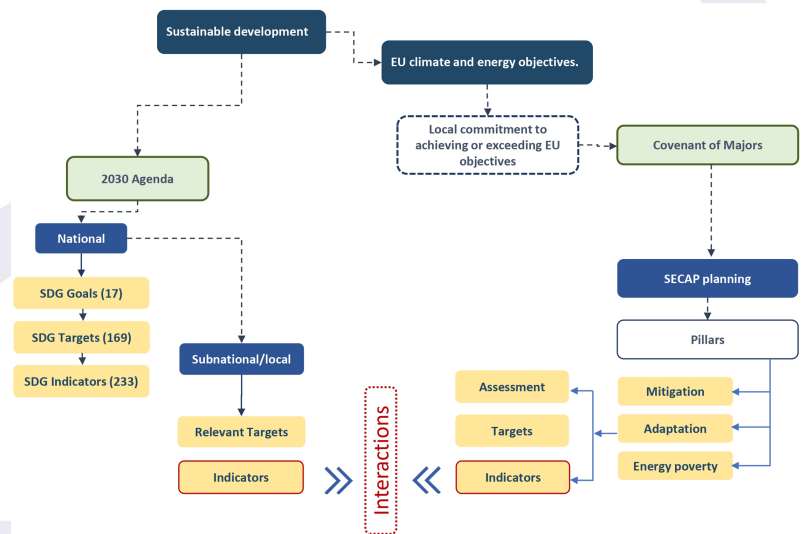
#SDGs and #SECAPs constitute two powerful instruments at the local level to foster the implementation of #Mitigation, #Adaptation, and #EnergyPoverty actions. #LOCALISED report "SOIs for SECAPs definition and assessment" introduces a set of 250 potential final indicators, the so-called SDG Oriented Indicators (SOIs), for assessing risks and vulnerabilities to #ClimateChange within both #SDGs and #SECAPs frameworks at once.

Since indicators are needed for several parts of the process, they need to be defined in an early project stage to understand the input data needed, the calculations required, and the output data provided. To take into consideration all these aspects, different steps were conducted to gather, filter and evaluate the list of indicators.

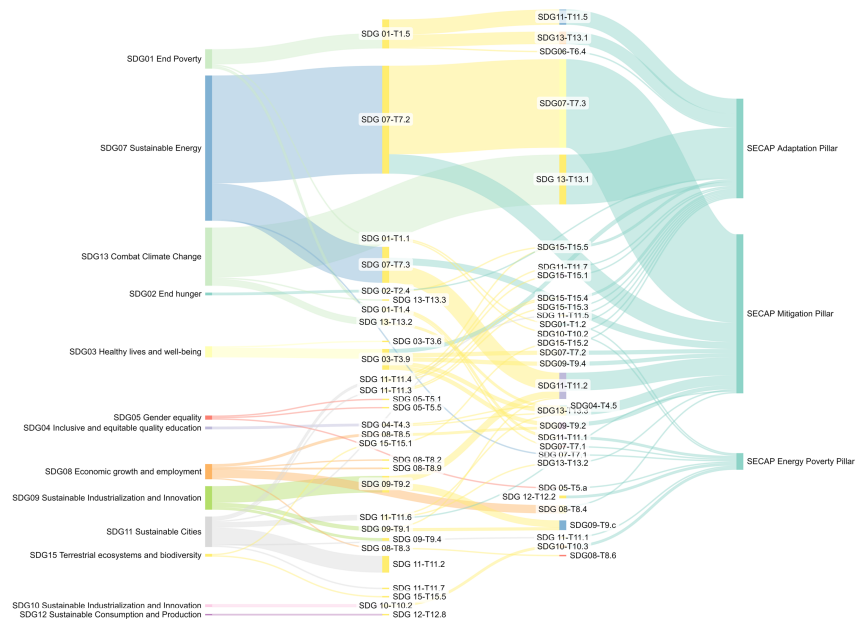
The 250 indicators presented outline the diversity of goals and targets that can be influenced by local actions plans and the multiple interactions between SDGs targets and SECAPs pillars.
